Jeri Bjorling Named Distinguished Volunteer



The late Jeri Bjorling was given the honor of this year's United Way of Hancock County Distinguished Volunteer Award. She was nominated by Diane Ragless, Anne Stapley and Karin Wilson.

Bjorling was nominated for her commitment to the community and her extensive volunteer experience with many nonprofit organizations. Bjorling served as United Way board chair for 2011. She also served as the Salvation Army liaison for United Way. She served as board chair and served on numerous committees

for Camp Fire USA Northwest Ohio Council and was part of the original "On Behalf of Youth" luncheon committee. Bjorling also volunteered for Children's Mentoring Connection, Handbags That Help, Hope House of Findlay, American Business Women's Association, and Hancock Reads. She was a past deacon at First Presbyterian Church and a driving force behind Camp Fire's Absolutely Incredible Kid Day letter writing campaign. She was on the Hancock County Saves advisory committee and was an advisory board member. She was a past board member for the Findlay Hancock County Chamber of Commerce and served on various committees. She was the first female Kiwanis member and a graduate of Hancock Leadership. Bjorling was also the first recipient of the Athena Award, given by the Findlay Hancock County Alliance in 2000. The Athena is awarded to women in Hancock County for professional excellence, community service and for actively assisting women in their attainment of professional excellence and leadership skills.

At the time of her passing, Bjorling was employed at Rowmark. She also worked at First Federal Bank and Huntington Bank. During her career, she was well known for being an integral part of the volunteer spirit that drove others in these companies to be community leaders.

Wilson said, "With Jeri, it was about the sincere desire to help. She was the one in a thousand whose motivations were pure – always thinking that perhaps she could help make someone else's road easier, or brighter, or more productive or more successful. I would like to nominate Jeri on behalf of all who looked to her and found encouragement, inspiration, motivation, vision, perspective and whatever else they might have been looking for."

Mikayla Brown Selected as Secor Scholar

Mikayla Brown, a senior at Findlay High School, has been selected as this year's United Way Foundation Secor Scholar. The \$2,000 renewable Secor Scholarship was established as a memorial to the Steven and Doris Secor bequest. It is awarded to a high school senior or high school graduate living in Findlay or Hancock County who plans to attend an accredited institution of higher learning to pursue any undergraduate field of study, full-time in the subsequent academic year. The candidate must exhibit a strong commitment to service, volunteering, extracurricular involvement and academic excellence.

Brown, the daughter of Carmen and Garth Brown, was selected because of her volunteer experience and leadership.



"Mikayla has provided leadership in many instances over the past few years. She has been an outstanding 4-H Camp Counselor, State 4-H Ambassador, and a member of the Ohio 4-H Teen Council," said Susan Russel, retired Extension Educator, 4-H Youth Development. "I could always count on Mikayla to teach sessions, present skits, and represent our program very well." Brown also addressed the

Findlay City Schools board of education advocating on behalf of music education. Because of her advocacy, the Advanced Music Theory program was created.

Some of Brown's volunteer positions in the community include; secretary for the Findlay High School band, board member of Youth Advisory Board for Findlay Hancock County Public Library, and public relations officer for the Hancock County Junior Fair Board. She is a member of Jr. Statesmen of America. She intends to study American History/Government and Music Education at Hillsdale College.

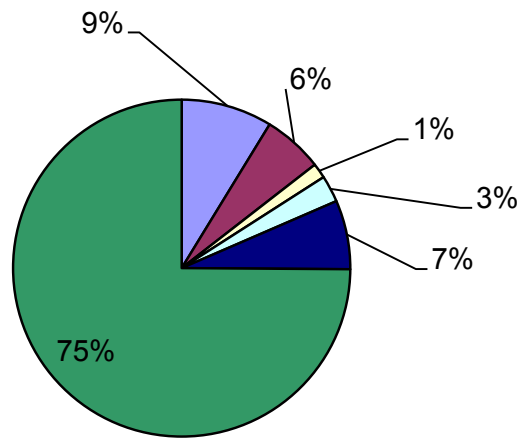

Your United Way investment at work in 2011:

American Red Cross-Hancock County Chapter

Disaster Services: provides immediate emergency needs such as shelter, food, clothing and more, to those affected by disasters in our community
Community Scholarships: provides funding based on household income, for adults to receive certification in Red Cross First Aid and Adult CPR/AED; provides funding for youth to receive Red Cross Babysitting Training
Service to Armed Forces: provides emergency communications for families of those in the military

Boy Scouts of America, Black Swamp Council

Learning for Life: helps young people mature and to prepare them to become responsible and caring adults
Boy Scouting: prepares young people to make ethical and moral choices over their lifetimes

Century Health

Peer Support Program: hires individuals who are recovering from a severe and persistent mental illness or addictions problem. These peers use their personal experience, training, and familiarity with formal and informal resources in the community to engage, support, educate, advocate and link clients and their families with critical resources essential to recovery. This service extends and enhances the existing treatment continuum by helping clients through their personal recovery journey.

Camp Fire USA of Northwest Ohio

Camp Fire Contributes: teaches young people how to handle themselves in unsafe situations and how to be of service to their community
Camp Fire Connects: builds caring, confident youth and future leaders

Cancer Patient Services

Patient Support: provides medical supplies, nutritional supplements, emotional support and education to cancer patients

CASA/GAL of Hancock County: recruits, trains and supports volunteer Court Appointed Special Advocates as they represent abused, neglected or dependent children in the courts

Children's Mentoring Connection

Mentoring Youth at Risk: recruits and screens adult volunteers to serve as mentors to children

Challenged Champions: utilizes equine as a tool while riding for physical, emotional, and mental rehabilitation, and for Alternative School Students, as a learning tool through equine assisted activities and therapies using physical, cognitive, emotional interaction during classes and hands on workshops to provide an environment of learning and self-discovery.

Family Resource Center of Northwest Ohio

Bright Beginnings: focuses on early childhood programming
Community Prevention: focuses on tobacco and alcohol abuse prevention
Hancock Addiction Prevention Program for Youth (HAPPY): a peer-to-peer prevention program



Findlay Hope House for the Homeless

Housing Office: provides assistance and referrals about housing to low-income people
Independence Project: assists those who currently have a home but are at risk of becoming homeless
Hope House Shelter: provides safe, decent, affordable housing to bridge the gap between emergency shelter and permanent housing for women and single men with children
Bridges Out of Poverty: bringing all classes, races, sectors, and political persuasions to the table to address all causes of poverty and create a sustainable community

Girl Scouts of Western Ohio

Personal and Leadership Development: promotes girls' personal growth and leadership development through a coordinated, progressive series of activities and experiences that help them become socially, morally, emotionally, physically and cognitively competent.

Hancock County Saves: promote and increase saving and debt reduction to produce financial stability

HHWP Community Action Commission

Hancock Area Transportation Services (HATS): a public transportation program taking people to work, health appointments and more
Ohio Benefit Bank: provides low to moderate income families with various federal benefit programs including tax preparation and foreclosure mitigation counseling

Open Arms Domestic Violence & Rape Crisis Services

Adult Services: provides immediate shelter for persons fleeing from violence
Child Services: screening for abuse, conducting support groups for children, and providing supervised visits
Violence Recovery: for offenders focused on taking responsibility and changing behavior

Salvation Army

Character Development-Youth at Risk: provides social interaction, recreation, education and nutrition for youth at risk
Comprehensive Emergency Assistance: short term financial assistance and life skills training for families and individuals experiencing short term emergencies

West Ohio Food Bank: food distribution program, providing food through mobile food pantries and to local food banks

YMCA

Access Program: makes services accessible to low-income families while still requiring a financial contribution, allowing the family to take ownership and regard themselves as a contributing member to the YMCA and community
Child Care: provides educational, social and physical development while also assisting low-income families with child care expenses
Feed A Child: providing weekend food for children in need.
